## Billing company contract not renewed

Another local community will cease the practice of billing insurance companies and drivers for the cost of sending emergency responders to auto accidents after a Dayton Daily News investigation of the practice.

Miami Twp. won't renew its contract with Springfield-based billing company Cost Recovery Corp. when it expires March 1, according to Fire Chief Matthew Queen.

Queen said the decision was made by the Miami Valley Fire District board as the township and city of Miamisburg plan to merge into the joint district this year, with Queen as chief.

"There was a lot of background work that was involved," Queen said. The \$20,000 the township received in revenue wasn't worth that effort, he said.

Miami Twp. joins Springfield and Franklin in canceling or not renewing its contract after the Dayton Daily News reported the company was billing more than local leaders realized.

Company officials say there were some billing errors and miscommunications, but they are in line with all of their contracts. The company sends bills to insurance companies and sometimes drivers on behalf of jurisdictions to recoup the cost of having police and fire respond to noninjury accidents.

Other communities, such as Vandalia and Sugarcreek Twp., are reviewing their contracts, officials there said. JOSH SWEIGART
